1. The Barrett Removals vans are Mitsubishi Fuso trucks, diesel engines and long wheeled based.
2. Barrett Removals formal quotation currency is £.
3. Barrett Removals is not a VAT registered company.
4. Barrett Removals is a limited company.
5. Any quotation given to you verbally, is an estimate
6. The quoted price is subject to the final cost of your removal job, subject to terms and conditions.
7. All home removals are quoted independently for 8 hours maximum, time after the 8 hours will be an additional hourly rate.
8. All charges apply from arrival at property A (loading) to the departure of property B (unloading)
9. Barrett Removals reserves the right to refer the removal job to another approved removal company on the day of the removal.
10. By discussion of Barrett Removals and the client we can dismantle or assemble a unit/system of furniture (flat packs, fitment or fittings). Disconnect, reconnect, or reassemble appliances, fixtures, fittings and equipment. Any item not discussed with endure an additional charge of £30 per item.
11. Parking charges/fines, tolls, low emission zones whilst carrying out services on the client's behalf, will be charged to the client.
12. Barrett Removals possess goods in transit insurance for up to £10,000. Client excess is £250 as standard. Any claims to be pursued within 48 hours.
13. For ownership of the goods, by entering into this agreement, you guarantee that:
 - a. goods to be removed and/or stored are your own property or
 - b. The person who owns the items being moved has given consent.
14. The client should ensure that all goods to be moved have been place in the van before transit to new/second location.
15. The client should ensure that all their goods have been removed from the van before the van departs from the client's address.

16. Valuable items – jewellery, cash, prescription drugs, mirrors, televisions, ornaments, family heirlooms are taken by the client. Barrett Removals will not be held responsible for these items.
17. For insurance purposes, Barrett Removals will not transport paint cans, gas cannisters or pets.
18. Items packed by the client are the client's own risk when transported by Barrett Removals. Please ensure that all boxes are double skin, bubble skin lined. Wrap, stack plates individually and vertically and your own personal clothes are packed proficiently. Please ensure that loose items are packed in preferred box sizes. Strong bin liners may be used for soft, unbreakable items.
19. Cancellations: if for unforeseen circumstances Barrett Removals has to cancel your move, a full refund of your deposit will be returned.
20. Client postpone or cancellation: your deposit is rolled over to the next available date. The deposit is non-refundable.
21. Upon job completion please kindly pay by cash or BACS transferor in certain agreed cases within 7 days of the invoice date. Payments on accounts may be requested depending on the scale of the job.
